

# Inaugural CIPFA CfPS Councillors Conference – House of Commons 13 September 2018

This inaugural councillors' conference is designed to provide maximum support, guidance and advice to any council elected member on how best to fulfil their local democratic role. Together CIPFA and CfPS, supported by key sector leaders such as Lord Kerslake and Rob Whiteman, will outline current legislative, governance and funding challenges facing councillors (and their councils) and share thoughts, insight and updates on what this will mean in practice and how best to address these challenges.

#### **Consultation on CIPFA index of resilience for English councils**

There is still time to respond to CIPFA's consultation on plans to introduce a new index as a measure of local authority financial resilience, setting out the relative financial health of each English council.

CIPFA invites all interested parties to respond to questions it has put forward in the consultation, which can be downloaded **here**. The consultation closes on 24 August.

## Consultation on statutory override for IFRS 9 for authorities in England

MHCLG has now issued a **consultation on proposed statutory overrides** in England for the new standard. We would urge you to download the consultation and respond by the closing date of 28 September.

**Local government finance settlement 2019 to 2020: technical consultation**MHCLG have issued a **technical consultation** on the 2019/20 Local Government Finance Settlement, responses to which are invited by 18 September.

# **Local Authority Leasing Briefings and Consultation**

To support the implementation of IFRS 16 Leases in the Local Authority Accounting Code, CIPFA is producing a series of Briefings, the first of which is available on the **CIPFA website**. The briefings are designed to:

- update stakeholders on development of the approach to adoption of the standard in the Code by the CIPFA/LASAAC Local Authority Accounting Code Board (CIPFA/LASAAC); and
- assist with the implementation of the standard from both technical and practical perspectives.

Each briefing will focus on particular aspects of the standard while also updating stakeholders on latest developments. The first briefing focuses on recognition and measurement and the **adaptations to the Code for the adoption of IFRS 16.** 

<u>The Code consultation on IFRS 16</u> is still available for your responses, and will shape how the leasing standard is likely to be incorporated into the Accounting Code...but please hurry as consultation closes on 7 September.

#### 2019/20 Accounting Code consultation now available

The **2019/20 Code consultation** was launched in July and covers changes in accounting standards and other issues on which the CIPFA/LASAAC Local Authority Code Board wishes to seek interested parties' views. This includes 'narrow scope' amendments to IFRS including amendments to IFRS 9 Financial Instruments and IAS 19 Employee Benefits, legislative and policy changes, updates for the IFRS Conceptual Framework for Financial Reporting and the Code's approach to adaptations/interpretations and statutory adjustments. Consultation closes on 8 October.

### Midlands Regional Finance Business Partnering course confirmed

CIPFA is an advocate of the development of the Finance Business Partnering role in public bodies. Finance professionals in the public sector have developed their role by evaluating how they can best support their organisations in a strategic as well as operational sense. This adaptation in their role has enhanced the relationship between finance and non-finance professionals across the organisation, putting finance at the heart of decision making.

Details of this midlands-based course, the first of its kind to be held in the region, can be found on the <u>CIPFA website</u> and is due to commence on 6 September 2018 with the programme launch. The typical price for this six-module course is £2,200 plus VAT per delegate, but we have managed to secure this course at a special price of £1,950 plus VAT.
