Local Authority Accounting Conference

The summer technical update conference will take place via Zoom on Thursday [7 July](#). The conference focuses on the anticipated changes to the Local Authority Accounting Code, both following and in anticipation of important consultations.

One of the key areas being covered is infrastructure assets, following the recent emergency consultation that proposed temporary changes to the Code to address an issue raised by auditors. The primary focus area was the derecognition (removal of the carrying amount) of parts of local authority infrastructure assets as they are replaced. This session sets out the key issues and discusses both technical and practical responses and the planned solutions to them.

Other topics covered at the conference include the summer Code consultation, the impact of the deferral decision on IFRS 16 Leases, IFRS 17 Insurance Contracts, good practice in relation to audit evidence and working papers, audit committees and internal audit, sustainability reporting, and the latest developments on capital financing across England, Wales and Scotland.

Use of HM Treasury's Better Business Case approach for decision-making – Webinar - 7 July (2pm – 3.30pm)

HM Treasury's well-established Business Case approach provides a decision-making framework which stakeholders work through in a structured, staged manner. Decisions around alternative service delivery models can represent some of the more complex and are potentially contentious.

The business case approach provides a framework to work within, ensuring that appropriate questions are asked at the start of the process and that a series of stakeholder workshops are used to structure the decision-making.

The event, presented by Mark Williams from CIPFA's Public Sector Advisory team, will benefit anyone considering setting up an alternative service delivery arrangement, and will be helpful to those from a range of disciplines: including finance, commercial, project management and at a range of levels of seniority. The issues covered are common across all parts of public services including local government, health, and central government.
