The two-day conference was aimed at professionals working in public finance and accountancy in the UK and globally.

Secret Accountant – "Lasting Legacy"

The recent Olympic and Paralympic games held in Paris made me cast my mind back 12 years (is it really 12 years ?!?) to the London Olympics, the Danny Boyle directed opening ceremony (think Kynren on an unlimited budget!), Super Saturday (Can you remember who won the 3 gold medals for Team GB within the 44 minute period by the way? Answers below!)

The Olympic game's little brother, the Commonwealth Games has recently hit problems with Australia's Victoria State Government politicians unwilling to make the necessary investment to host the next games, scheduled for 2026. That must have been a difficult one to sell the Australian people with their love of Sport but if the business plan doesn't add up, even after attempting to quantify the unquantifiable "feel good" factor arising from such an event, sometimes difficult, and even unpopular decisions have to be made.

Interesting also to hear of Glasgow's interest in staging the games, even on a scaled back basis, and funded in part by AU \$200 million dollar compensation from the Victorian State Government in compensation for their withdrawal via the Commonwealth Games Fund – it must be true, Wikipedia says so (!). The Business Planning phase in both cases must have been interesting!

I was also lucky enough to attend the Commonwealth Games held in Birmingham in 2022, managing to attend an unusual sporting hattrick of Athletics, Boxing and Diving on consecutive days, where a "feel good" factor was certainly generated and that's no bull, whether named Ozzy or otherwise!

There was much talk at the time about the legacy for the country to be derived from staging the Olympics, particularly in terms of increased participation in sport and resulting measurable health benefits in reduced childhood obesity, though I am not particular certain if that was ever objectively and effectively measured.

Thought it may seem a little early for Christmas films, one of my particular favourites is "It's a Wonderful Life – surely you have seen it, the story of George Bailey, played by James Stewart. I won't spoil it but, courtesy of his Angel (Clarence) he truly gets to see the difference he has made to his Community – If you haven't seen it make sure you do, and even if you have, watch it again -
