- 4. 2021 Regional Development Plan and Budget.
 - (1). Development Plan 2021. (Paper SEO2103 from 11 May Council refers) This has been delivered wherever circumstances have made that possible through the ongoing Covid pandemic. It was revised this autumn as the 2022 Development Plan was prepared.
 - (2). Budget v Actual at 2 December 2021. (Paper SEO2124) This December statement shows income and expenditure to date, plus a first projection of the outturn for this year. Some items are estimates based on the original budget provision. Council is requested to note this statement and notify our regional treasurer of any additional items that may need to be included for 2021.
- 5.Regional Development Plan and draft Budget for 2022 (Paper SEO2125)
 The version attached was submitted to CIPFA to support our 2022 subvention bid of £18,000 which was approved. This plan was prepared mainly on a 'roll forward' basis from 2021, but with increased provision for regional student activity. Other budget related issues may be identified from discussion at this Council meeting. The present summary budget will be enhanced into the usual format for formal review and approval by Regional Council at our 2 February meeting.
- 6. Newly Qualified Members' certificate presentations 2022 The presentation ceremony held before the Annual Dinner proved to be successful with those able to attend. We have already committed in principle to a Spring 2022 ceremony and Council is invited to suggest formats, dates and the potential continuation of an Annual Dinner ceremony for 2022. An update for potential attendee numbers will be requested from CIPFA Membership for this meeting – my current estimate is approx.90 region-wide during 2022.
- 7. Mentoring Developments current proposals for 2022
 Planning for resumption of live sessions is paused at present. Tom England will advise whether it is feasible to consider restarting planning of virtual speed mentoring sessions yet.

Regional Council will be aware that I have given notice that I would like to retire from my present role in providing Development and Support (via JBCL) to deliver much of the Regional Council's decisions, events and raising sponsorship. There are several options which could follow on from the present arrangements and I propose that I should prepare a paper to set these out, for initial consideration at our 2 February meeting. The implications of IR35 for regional paid support, following recent dialogue with CIPFA HQ colleagues, will

also need to be considered, as successor arrangements are evaluated. I will, of course, commit to continuing to support the Regional Council requirements until any successor arrangements are in place.
