Providing Reassurance - Designing your Competitive Flexible Procedure and Assessment Summary

Purpose

This event has been developed to support contracting authorities design or obtain assurance that their competitive flexible procedure is Procurement Act 2023 compliant. Contracting authorities have been used to following process driven procurement procedures under the Public Contracts Regulations 2015, however the Procurement Act 2023 now offers contracting authorities an opportunity to design their own procurement process. This will give contracting authorities greater flexibilities to design procedures that meet their specific contract requirements. The catch however is that organisations will have to operate within the overarching principles and objectives under the Procurement Act 2023. In addition, the procurement procedure will have to be clearly documented and linked to the wide-ranging transparency obligations in the legislation to create certainty for all parties and avoid legal challenges.

To avoid getting caught out and having your procurements delayed or abandoned, this event has been scheduled to support practitioners. It will focus on the competitive flexible procedure and provide support and offer guidance to draft complaint documents.

- Practical explanation of how CAs can make the most of the new flexibilities and freedoms.
- Detail the scope and parameters to design your own procedure under the PA23.
- Understand how the principles and objectives will apply to the procedure.
