It is now over a year since the Provider Selection Regime (PSR) came into effect from 1 January 2024, with relevant authorities (NHS England, Integrated Care Boards, NHS trusts, NHS foundation trusts, local authorities and combined authorities) required to comply with the new rules when procuring Health Care Services within scope of the PSR. This event has been developed to provide a detailed practitioner overview of the PSR regime, which will act as a refresher for experienced colleagues and an introductory guide for those new to this area.
