

In my remaining time, CIPFA's Annual Conference 'Aligning Public Services- forging a sustainable legacy' is set to descend upon London and looks likely to be a sell-out event. I am particularly looking forward to the opportunity to explore how experts predict public finance will be affected by the change in government and what tools we practitioners need to continue to make services sustainable for communities.

Tax and accountability under CIPFA spotlight at African Congress

The third African Congress of Accountants (ACOA) opened in Mauritius on 12 May with a call for a stronger public sector accountancy profession, from training through to financial monitoring and reporting.

The Congress brought together African and international accountants from the public and private sectors in Mauritius under the banner 'Rising Africa partnering for results'.

Speakers agreed that African accountants should involve themselves more in the work of the international standards setting boards, and delegates backed the Pan African Federation of Accountants' intention to drive this process across the continent.

CIPFA ran three sessions at the conference, which attracted a large audience. Ian Ball. Chairman of CIPFA International spoke on public sector governance and reporting in Africa, and Integrated Reporting <IR>, while CIPFA

New landmark audit qualification launched by ICAS and CIPFA

CIPFA and ICAS (the Institute of Chartered Accountants of Scotland) are working together to produce a groundbreaking new joint qualification in both public and corporate sector audit.

The qualification will combine the unrivalled expertise and standing of both institutes to meet the needs of both the public and corporate sectors. This will also lead to dual designations from both ICAS and CIPFA for the students who train for this innovative new qualification.

The move responds to the growing need for accountants to be able to audit all entities in all sectors due to the mixed economu within which organisations now operate. The increasing fluidity between public and private sectors means many employers now require staff to have a registered audit status in both public and company audit.

This integrated qualification will be launched in September 2015, with a flexible delivery model that can be delivered face-to-face, or as a blended model through the use of technology.

It reflects radical changes made to public sector audit in the past few years with the abolition of the Audit Commission and the introduction of a new public sector audit regime.


Fraud and corruption survey launched

In May, the CIPFA Counter Fraud Centre launched its official survey on fraud and corruption.

Endorsed by the Local Government Association, it examines the levels of fraud and corruption that have been detected across English local authorities in the 2014/2015 financial year.

The results will be published in the summer and will provide the essential intelligence needed to more effectively tackle fraud and corruption. Authorities have been asked to share the number of investigations they have undertaken, the types of fraud encountered and the emerging trends. The survey also includes questions commissioned by the Fighting Fraud and Corruption Locally Board, to give an even fuller picture of the preparedness and actions being taken by local authorities across the country.

Improving public financial management in Malaysia

CIPFA, The Malaysian Institute of Accountants (MIA) and The Malaysian Institute of Certified Public Accountants (MICPA) have signed an agreement to strengthen public financial management by developing skills and increasing capacity in Malaysia.

The signing ceremony took place in Kuala Lumpur, Malaysia at the Government Accrual Accounting Conference with Ian Ball, Chair, CIPFA International in attendance.

Commenting on the MoU, Ian Ball, Chair, CIPFA International said:

'It is welcome news that our three bodies have come together to advance public financial management in Malaysia by forming a collaborative relationship that will be committed to developing practice within the country.'

The relationship has sparked several initiatives already. A delegation from CIPFA, MIA and MICPA met with

the Accountant General and Auditor General of Malaysia in Putrajaya, where discussions centred on developing finance capability, meeting the challenges of accrual accounting in 2016, sustainability, governance, IPSAS standards and MPSAS - the Malaysian equivalent.

Malaysia has an Economic Transformation Programme and vision to become a high-income, knowledgebased economy by 2020.

Ian Ball, Ian Carruthers and Brian Donnellan from CIPFA also attended an interactive workshop for CIPFA students working for UNDP and WHO, held in the UNDP's Global Shared Services Centre in Cyberjaya, an IT-themed city in the Multimedia Super Corridor in Malaysia.

CIPFA calls for a modernised fiscal framework for Scotland

CIPFA has called on the Scottish Government to seize the opportunity for fundamental change to the way it controls its finances as part of oral evidence given to the Scottish Parliament Finance Committee's enquiry into Scotland's fiscal framework on 13 May.

It follows a submission to the enquiry from the Institute in which CIPFA argued that it is time for the Scottish Government to update its fiscal framework so that it can support a modern and forward-looking system of government in Scotland.

Speaking after the evidence session in the Scottish Parliament, Head of CIPFA Scotland, Don Peebles said:

'If the Scottish Government heeds our advice then any new system will be underpinned by strong prudent principles that would ensure sustainability and affordability backed by a balance sheet that displays the real financial position of the Scottish Government.'

CIPFA submitted evidence to the Scottish Parliament Finance Committee's enquiry into Scotland's Fiscal framework. This submission argued that to have a sustainable framework the Government has to have the appropriate level of financial information on Scotland's overall finances and that this can only be achieved through a balance sheet for the Scottish public sector.

Whistleblowing e-learning package

The CIPFA Counter Fraud Centre has joined forces with its founding partner Mazars and the whistleblowing charity Public Concern at Work to develop an e-learning package on whistleblowing.

Launching this month, the tool has been designed for use in organisations where there is a whistleblowing policy in place. It highlights the importance of the policy and explains what whistleblowing is, why it matters and how to blow the whistle.

Using high-profile examples and sectorspecific case studies, the e-learning package will be available to purchase from the CIPFA Counter Fraud Centre website. Initially, there will be versions specifically aimed at local authorities and charities.



CIPFA to build financial infrastructure in Nepal

News from Nepal has been dominated by the earthquakes that have devastated vast areas of the country, but looking to the future, CIPFA is playing its part in securing the country's financial foundations.

CIPFA has been invited by the Nepal government and the World Bank to offer a proposal to implement its suite of international PFM (IPFM) qualifications in the country, along with other training, and to begin building the capacity to sustain these much-needed initiatives over the longer term.

The government wants to create a PFM academy in Nepal and is looking to CIPFA to offer advice on achieving this, and to train the trainers. This request was sparked by CIPFA's work in Bangladesh, where our IPFM qualifications are being used to train staff in the Office of the Comptroller and Auditor General.

In March, Gordon Ferrier, Head of Global Membership at CIPFA attended three international public finance events in Kathmandu. A meeting of the Public Sector Committee of the Confederation of Asian and Pacific Accountants

(CAPA) was followed by a public financial management roundtable event and an international PFM conference, at which Gordon made a presentation on the professionalisation of PFM around the world.

The events were attended by representatives from the Nepalese government, donors including the World Bank, CAPA members and other stakeholders.

CIPFA member Mark O'Donnell has been caught up in the earthquakes, working in Kathmandu with DFID on their Fiduciary Risk Assessment programme, where he has witnessed the scale of the disaster and the dire situation with regard to food, water and electricity.

Full government accounts show net liabilities up by £624bn over the past five years

Analysis in a briefing note by CIPFA on the Whole of Government Accounts (WGA) shows that the UK's public sector net liabilities, the gap between what the country owns and what it owes, increased by £224bn in 2013/2014 to £1.852 trillion.

The yearly increase alone would equate to an additional £8,389 of financial liabilities for each household in Britain.

In total the net public sector liabilities of the UK are equivalent to £69,363 for every household in the country.

The WGA published late March covers the financial year 2013/2014 and show that over the course of the past five years (since 2009/2010) the total net liabilities of the UK public sector have increased by £624bn or by £23,370 per UK household.

The publication of WGA, which is available online, improves the transparency of government spending decisions and their impacts on the public finances.



Future Focused Finance: new collaboration between finance and health professions

Moves to boost the role of the finance profession in the NHS require a new collaboration between accountants and clinicians, as well as an improved understanding of costs across the health service.

CIPFA recently hosted a roundtable event on the Future Focused Finance (FFF) initiative where experts in health, research, local and central government discussed how NHS finance staff can help clinical staff achieve better value for money.

Here, Paul Carey-Kent, CIPFA's Health Policy Advisor, and David Ellcock, Programme Director of Future-Focused Finance, state the case for this collaboration.

Need for positive partnerships in the NHS

At a time of unprecedented change and tight budgets in the health service, the Future Focused Finance initiative is taking steps to ensure that accountants achieve best possible value for public money by working closely with clinical colleagues.

At the roundtable event at CIPFA on March 30. Caroline Clarke, the senior responsible officer for FFF's work on best possible value, explained how the programme would equip the health service's finance community with the tools, skills and attitudes needed to drive change.

Attendees agreed there was a need to concentrate on outcomes for both patients and the whole population, with a focus on people living independently as long as possible with minimum medical intervention, rather than on increased health activity.

Doctors present at the discussion said financial decisions also had to be practical, but too many were made on the instinctive grounds that more spending must be good – for example on extra nurses – without an explanation about what outcomes will be improved.

Delivering this shift will require better ways of making the key allocative decisions, in which finance is key. How can we spend more on prevention and less on cure? How can we decide between the unquantifiable aspects of competing clinical strategies?

It is therefore vital to establish a new working partnership between clinicians and finance staff. A shared agenda around patient and population outcomes is required, tied to opportunity costing. Every decision to spend is another opportunity lost – so is it the right decision in that context? Accountants should see themselves as

contributing to those health goals, and clinicians must accept that money needs to be controlled.

To contribute to this new relationship, finance staff need to be broad-based business enablers, with an outwardlooking understanding of how the whole public sector works. They mustn't take a narrowly organisational or numerical point of view. They should be "porpoising" – that is diving down into the detail when necessary but also leaping up to the strategic view. They need soft skills so clinicians involve them in decisions, and both groups need to be able to put themselves in each other's shoes. It might be too much to hope for perfection, but practical, porpoising finance staff will at least be making progress.

From bean counters to value makers

Future Focused Finance (FFF) is changing the perception and role of finance staff in the NHS.

Common misconceptions that doctors, nurses and other clinical staff have of finance staff in the NHS – that they're bean counters only interested in profit may have their roots in the way things have worked in the past. But things are changing.

The NHS is facing an unprecedented challenge, with an ageing population, rising costs and government austerity. An estimated £30bn needs to be found over the next five years to keep the NHS sustainable. And this can only be achieved if clinicians get involved in decision-making that brings best value for patients - and taxpayers. Simon Stevens, the Chief Executive of NHS England says he 'thinks like a patient and acts like a taxpayer'.

One year ago, finance leaders from six national health organisations decided to do something practical to get all aspects of NHS finance fit for a 21stcentury health service.

With the support of CIPFA and the wider professional community, Future-Focused Finance was launched. It aims to change the perceptions of NHS finance; develop new skill-sets and competencies for finance staff; create a suite of best practice models for decision-making for best value; and engage clinicians, patients and the public in the financial challenges facing the NHS. Its five-year mission is 'Making People Count', with a commitment to far-reaching, long-term change.

Clinicians make most of the day-to-day decisions on patient care, and are also central to big investment decisions, such as new equipment or drugs. Yet very few are aware of the costs involved and even fewer have any formal training in finance. Having the finance team in a virtual silo removed from the realities of patient care does not help.

FFF aims to show clinicians the financial impact of the decisions theu take, and to help them make decisions that give best value for patients. We

have recruited over 100 volunteers as ambassadors for the programme, and a similar number as 'finance educators' to train clinicians and non-financial staff. These groups are already changing perceptions of finance within the NHS, and many participants are also finding and developing new skills.

One year in, this is encouraging, but there remains a great deal to do especially in clinical engagement. The financial challenges facing the NHS can seem daunting, but if finance staff, managers and clinicians can work together to make best-value decisions for patients, there is hope that they can be overcome.

CIPFA calls for devolved financial powers as public backs local decision making

CIPFA has called upon all political parties to commit to devolution by default of both spending and tax raising powers. The call came ahead of the general election after a survey by YouGov for the institute showed that 77% of the UK population believed that regions and local areas should be in control of their own budget and spending.

Over three quarters (78%) of the UK population also said that accountability for how money was spent should also be placed at a local level rather than central government.

This came as the survey, which results are available online, showed that while trust in politicians was low across the board, local politicians were trusted twice as much as national figures. The survey showed that only 16% of the UK population trusted politicians based in Westminster while 32% trust local elected politicians.

The Governance Review Working Party has spent the last three months taking evidence and your responses into account.


The consultation response was published on 1 June alongside AGM material and contains an outline of the working party's final proposals.

All the proposals have been endorsed by CIPFA's Council, and were developed according to the review's priorities and aim to strengthen our whole organisation in line with CIPFA and IFAC's international framework on good governance in the public sector. The proposals are centred around:

- strengthening the strategic role of Council
- achieving a greater regional focus
- increasing the impact and capacity of the honorary officer team.

Please take the time to look at this response and vote on the relevant motions electronically or by post - or in person if you're attending the AGM on 7 July at our Annual Conference. If the vote is successful, we will apply to the Privy Council to make changes to the Bye-Laws, and the new rules should come into force in autumn 2015.

Governance review response

CIPFA Public Service Audit Award

How effective is your finance function?

Finance teams in local authorities have worked tirelessly to identify important savings and allocate resources more efficiently. Budget-making decisions have a considerable impact on the council as a whole, and it is important to gain feedback from employees on how they are supported through the budget process.

CIPFA's Finance Users Survey will allow organisations to identify any issues regarding the services provided by the finance function, and gain insights into employee awareness of the relevant processes. Such feedback can help identify areas for improvement, understand training requirements and ultimately streamline the finance function.

The flexibility of the survey means that it can be used throughout the year, according to the needs of the organisation. For example, you might want to run one survey during the budget setting process, and another at a later date on budget management, finance/budget support and other aspects of the finance department. In addition, as more organisations complete the survey, there will be opportunities to obtain and share best practice.

Right to Buy: sums don't add up

The 2015 Conservative manifesto signalled a clear intention to pursue a Right to Buy (RTB) policy with housing associations. In 1980 a similar suggestion was omitted from the RTB legislation following heavy lobbying from the housing sector.

The arguments 35 years ago are similar to the arguments being presented today - housing stock reduction, asset loss and social cleansing. However, the funding argument, while still clearly relevant, has moved on, following the government's decisions to interlink the policy of high value stock sale to the funding of RTB for housing associations.

The funding streams suggested to pay for this policy lack detail and there is a considerable financial risk attached to some of the assumptions made. With the importance of stable housing in supporting economic growth, the maths around this calculation need careful checking, argues the Chair of CIPFA's housing panel Ken Lee in Public Finance.

Action under CIPFA's Disciplinary Scheme

The Institute's independent regulatory committees have taken action in relation to Mr Alan Welch. With his consent. the Institute's Investigations Committee issued him with a reprimand on 26 March 2015 in relation to his failure to pay car parking charges at his NHS place of work.

Update from Paul Woolston, Chairman of CIPFA Business

It recently announced a new strategic partnership with BAE Systems Applied Intelligence and will be working on developing a number of tools, including an advanced data sharing hub. The Centre's new qualifications are also running successfully; the first cohort of new counter fraud specialists completed their studies in April and their feedback has already been extremely positive.

CIPFA's Academies Hub is another example of delivering services that are integral to our communities. The Hub helps with the business end of academies, promoting good financial management and governance.

It recently had a very successful platform at the Academies Show in London, where Giles Orr addressed attendees on what's next for academies and the way they run their finances. Giles managed to engage with potential stakeholders on why governance and transparency are key to financial processes and how things will change in the future.

The CCFC and the Academies Hub are just some of the areas where CIPFA are leading the way in improving public financial management whilst supporting its members. Across the whole Institute I have seen a real drive to improve the services that we offer and I am looking forward to continuing to play my part in this.

Health and social care integration: what CIPFA thinks

The integration of health with social care is a political priority. Our briefing paper Moving ahead with integration spells out three conditions needed to make this integration a reality.

First, the government needs to recognise that combining two financially challenged systems will not in itself increase resources available. All the indications are that additional funding or changes to the regime for charging will also be needed.

Second, it is critical that the new government moves quickly to address the financial and policy framework for integration in 2016-2017 and beyond.

Third, central and local health and social care leaders must take the right local action to facilitate successful integration, concentrating on frontline practice.

Local government in England is responsible for the management and control of £55bn each financial year. But public services are undergoing radical change, experiencing unprecedented reductions in expenditure.

All council treasurers are acutely aware that their financial position means that whatever service delivery models are agreed in the future, they will have to cost a lot less than at present and involve far less resources.

The emerging consensus is that local councils will become effectively commissioning bodies and will be more reliant on external organisations to deliver their services.

Obituary: Ivor Craddock

Ivor Craddock, a long standing member of CIPFA, died on 31 March 2015 aged 92 after a lengthy illness.

In the early days of his career, from 1947 to 1954 he worked under Dr Hedley Marshall for Coventry City Council as an Accountancy Assistant. He then moved to Widnes Borough Council for five years before being appointed Chief Accountant for Crayford District Council in 1959. His final career move was to Maidstone Borough Council where he became Borough Treasurer in 1974, retiring in 1987.

Tony Jeyes who worked for Ivor in the Maidstone office wrote this tribute:

'A natural leader, Mr Craddock was a strong willed but fair man who was always willing to listen to alternative views. He was particularly gifted at bringing the best out of people, listening patiently to either personal or business problems and then offering advice and guidance that would usually result in a solution being found, even if that meant acceptance that there was none!

'He took everyone under his wing, sharing his knowledge and experience to make them better people. He is greatly missed by all who knew him.'

General election candidate beaten but not defeated

CIPFA member Frank Jackson, a British pensioner living in France who stood against Boris Johnson to highlight the injustice of the expat voting ban, won only 14 votes in the election but was happy with the publicity his campaign attracted.

A former Falklands Islands government treasurer, Mr Jackson no longer has the right to vote in the UK after living abroad for 20 years.

He stood for election to highlight the fact that he could run for office, but not vote. The Conservative win is good news for his campaign, because the Party has pledged to abolish the 15-year rule and let British expats keep their right to vote for life.

'I am happy with the result,' said Mr Jackson, 'I got 14 votes which is better than I expected. I didn't insist on a recount.'

Meet our tutors

Matt Pinnock, CETC Senior Trainer Matt has been with CETC for over two years, joining after ten years in a variety of local government roles, during which time he had qualified as a CIPFA member with CETC and now works with many of his old trainers.

Matt teaches MA, FM, BM and GPPE as well as contributing towards delivery of the Strategic Financial Management course. More recently, he has spent time on Train the Trainer courses with our international partners.

'In April I spent a few days in Macedonia delivering a course to a group of prospective financial management tutors. This was a challenge because the style of delivery was different (I was not teaching the content of the course but how to teach it) and that English was not their first language (despite it being of a high standard). The days were scheduled to run from 09.00 but this was often interpreted as 09.15 and there was a relaxed attitude to the lunch "hour" - however, when work was required they knuckled down and were very keen to learn.

'The group were very welcoming and recommended some good spots for lunch and dinner. One even took me out for a traditional Macedonian meal one evening. The food was plentiful, Mediterranean in style but with some Turkish and western influences; there was a definite eating out culture.

'Macedonia's capital, Skopje, is in the process of being rebuilt. It is primarily communist-style stock, rebuilt after a

devastating earthquake in the 1960s, but this is being replaced with stone Georgian style buildings that need to be weathered for a couple of hundred years before they look right.

There is plenty of history – it was under Ottoman rule for five centuries before becoming part of Yugoslavia. After the Balkans war, it gained independence peacefully in the break-up of Yugoslavia, though it has had longrunning disputes with Greece about its name - at the UN it has to be called the Former Yugoslav Republic of Macedonia.

'It was a fascinating place to be with the history and different culture (but just as many similarities as differences). CIPFA has ongoing work in the area so I hope to be able to revisit the area soon.'

Online exams from winter 2015

CIPFA are moving all examinations from paper-based to online for their new-look Professional Qualification (PQ) and IPFM.

Online methods of assessment will be made available to students' worldwide training for their CIPFA qualifications, providing a flexible route into the profession, allowing students to take their exam at their workplace or home.

Financial Accounting and Management Accounting will be the first to be tested by e-assessment in December 2015; the full roll out across the syllabus begins in June 2016.

The same level of competence will be required to achieve CPFA – there will be no dropping of standards, CIPFA will still test complex public financial management skills.

Practice and mock exams will be made available so students can prepare for the real thing.
