

#### **Be prepared**

By the time you read this a new Government will be deciding the policies that will shape public services for the foreseeable future. As the Institute for Fiscal Studies reminded us during the election campaign – there was remarkably little debate from the major political parties on the detail. Given the parlous state of public finances, this might have appeared surprising, and it certainly gave rise to much critical analysis from the media.

However, I think the reluctance of senior politicians to discuss these matters reflected a similar reluctance on the part of the public. Even talking to colleagues around the country I have detected what I called a 'collective flinching' in the face of the current situation.

But without discussion, we cannot prepare. And being prepared is a key part of the finance professionals' role. In this post-election period CIPFA members must be on top of their game if they are to meet the challenges ahead.

So CIPFA continues to follow up on the key issues affecting public services and to work with partners like Solace in updating and carrying forward the analysis that we began with After the Downturn. I and my senior colleagues are also acutely aware of the considerable pressure on individual CIPFA members and the Institute will continue to support, professionally and practically, our members at this difficult time.

### **CIPFA annual conference 2010**

As Spreadsheet goes to print, we're gearing up for what promises to be an exceptional CIPFA annual conference. The first coalition government in over 30 years is deciding what could be the most radical overhaul of the public services in living memory – and all in our 125 anniversary year.

The main programme promises some lively debate with Göran Persson setting out the lessons from Sweden, followed by Robert Chote from the Institute of Fiscal Studies who, with Bobby Duffy from Ipsos MORI Social Research Institute, explores the public spending challenges ahead for the UK. Colm McCarthy, whose report on the public sector in the Republic of Ireland has caused so much controversy talks about the Irish experience.

The conference will be the first opportunity for you to discuss the follow up to our pre-election manifesto. *After the manifesto: delivering the plan* sets out the steps we believe are critical to building an effective strategy for restoring order and balance to public finances. In it, we urge Government to take leadership to create simple, well-designed and lasting structures for public service delivery.

### The Head of Internal Audit – what do you think?

The role of Head of Internal Audit (HIA) is instrumental in driving improvements in good governance and is now more important than ever. To support HIAs in their work, CIPFA has published a draft statement on the role of the head of internal audit in public sector organisations. The statement, which can be downloaded at cipfa.org.uk/roleoftheHIA sets the standard for HIAs and can help audit committees and others judge how well their HIA meets that standard.

The draft statement, which will receive its main launch at Annual Conference, stimulated some lively debate when it was pre-launched by President Roger Latham at the CIPFA Audit conference in May.

The draft is now out for consultation ahead of the issue of the final statement in the autumn. Your comments are essential to understanding how best we can help maximise the impact of HIAs.

Mike More, Chief Executive at Westminster City Council and chair of the statement's steering group said:

'As a former head of internal audit I know the impact that internal audit can and should have in helping organisations flourish. I hope that this statement will generate a wide debate and set a standard for HIAs to aspire to and for audit committees, and others to support HIAs to get there'

We urge you to contribute to the debate and to circulate it to interested colleagues, especially audit committees to ensure as wide an airing as possible. We have in mind four specific questions regarding the statement, but are keen to get views on any aspect.

- 1. Do the five principles cover the right ground? If not, how might they be amended or augmented?
- 2. Are there any aspects of the statement that would reduce its relevance, or prevent it being applied in any areas of the public services? Please explain any potential issues and suggest appropriate alternatives.
- 3. Do you support CIPFA's view that organisations should confirm compliance with the statement in their annual governance statements?
- 4. How should CIPFA follow up the statement to help HIAs, audit committees and others make best use of audit
  - resources and maximise the impact that they make?

# President's diary

Up to the finishing line – in which your President completes his tour of CIPFA regions, is in at the start of what could be a great adventure, and speaks about some of the key issues facing the new Government.

ne of the little personal objectives I set myself as your President was to make at least one visit to each of the CIPFA regions during my Presidential year. I'm glad to say, with one exception, I have achieved this, although when I set off on my travels again at the beginning of this year I had yet to visit Scotland, North East, South Wales and West of England, and Wales.

#### **CIPFA Scotland annual conference**

Travelling by rail to Dundee for the CIPFA Scotland Conference gave Angela and I the opportunity to travel further north by rail than we had ever done before. I've seen more of the UK rail network this year than I think I've seen in my whole life. But with its crossing of the Forth Rail Bridge and the Tay Bridge this journey was particularly noteworthy.

# All our yesterdays – bright new tomorrows

he Institute was set up in 1885, had as its objective 'the discussion of questions relating to corporate finance and accounts, the interchange of opinions and experience and generally to promote the efficiency of its members'. The Institute had its roots in local government which at that time comprised virtually all the public services provided by the public sector.

Local institutions in the last decades of the 19th century are described in the Institute's first official history as 'The fitful attempts to remedy the eccentricities and remove the shortcomings of our local institutions showed no cohesion, no system, and no guiding principle. Everything was done piecemeal. In the eighteen-seventies English local government could be fitly described as a chaos of areas, a chaos of authorities and a chaos of rates; the citizen lived in a jungle of jurisdictions.'

Professional education hardly existed at all in those early days. Text books were few and considered to be of indifferent quality. In effect our founders had to write their own. Their practice outran their theory; and later theory developed out of their practice. They came to their work when municipal life, municipal finance and accountancy did not possess a recognised technique. A start was made by encouraging the use of income and expenditure rather than receipts and payments as the basis of accounting. By 1889 the Institute Council found it necessary to inform the membership that the accounts should include the income and expenditure of each year, 'the income being shown on the right hand page of the published abstract and expenditure on the left hand page.' Not all was sweetness and light. Earlier, the Institute offered to give evidence to the Royal Commission on Local Taxation in 1897. After surveying the membership the Institute concluded that on reflection it should not do so because of the diversity of opinions expressed.

### Fast forward to the swinging sixties and swingeing seventies

By the middle of the twentieth century a body of professional knowledge, norms and conventions had been established. The country had been through the First World War, the 'roaring twenties', the Great Depression, the Second World War, post war reconstruction, the creation of the welfare state including the National Health Service, extended education and slum clearance and a massive programme of municipal housing. The basic disciplines of financial planning, budgeting, safe and efficient paying and receiving, borrowing and investing, accounting and auditing were well established.

Hedley Marshall, City Treasurer of Coventry, brought these disciplines to life in his masterly work *Financial Administration in Local Government* published in 1960 (price £2). A glance at the book's table of contents shows how the role of the Chief Finance Officer had developed – financial policy adviser, paymaster, collector of income, accountant, internal auditor, treasury and investment manager together with ever growing corporate responsibilities. Marshall aimed to explain crisply how the demands on the finance function could be met through integrity, professionalism and shrewdness emphasising that the finance function was not an end in itself. Marshall wrote that 'financial staff should remember that their function is to advise, to suggest implications, to warn and persuade, but not to dictate; for financial administration is part of a larger whole and

#### **Making their mark**

Our early leaders were naturally much concerned with day to day financial control and probity but it is interesting to note that those leaders still made their mark on national public finance policy making. Evidence was submitted to:

- The Joint Select Committee on Municipal Trading 1903
- The Departmental Committee on the Accounts of local Authorities 1907
- The Select Committee on the Application of Sinking Funds in the Exercise of borrowing Powers 1909
- The Royal Commission on Income Tax 1919



financial considerations are not necessarily paramount.

In 1973 Marshall would update his work in collaboration with Clive Willetts who Marshall wrote 'had been generously seconded to the Institute of Local Government Studies at the University of Birmingham by Worcestershire County Council'. Financial Management in Local Government was published at a price of £3.25.

Progressive authorities were judged to be those actively working towards unified management under the banner of corporate management and playing greater attention to the community's needs as a whole. If a local authority was a unity then finance must be integrated into management. Marshall used the term the 'financial thread' to emphasise that finance is 'everybody's business'.

Ideas about management in local government in the 1970s were fermenting. The buzz words of the decade include for example:

- planned programme budgeting systems
- mangement by objectives
- ouput measurement
- operational research and simulation
- management audit
- cost benefit analysis
- inflation accounting
- multi-purpose budgeting
- computer auditing
- management information integration
- a behavioural approach to the role and objectives of internal audit.

These ideas would be tested by the great local government structural reorganisation of 1974 and later in the decade when the real growth in public spending on local services would be reversed as financial and economic crisis turned into the recession of the early 1980s.



### The 1980s - new tricks for a new era and ready for anything?

Economy, efficiency and effectiveness became more prominent as we moved into an era of compulsory competitive tendering of local services. The statutory tendering process gave fresh impetus to commissioning and procurement, being clear about specifying the service required and financial risks and penalties. In-house bids for work had to be priced. The competitive discipline was expected to drive down costs and raise performance. For decades inter-authority cost



comparisons had been led by the Institute. There was now a fresh impetus to benchmark costs.

By the middle of the decade we were preparing for another local government reorganisation with the abolition of the Greater London Council and metropolitan county councils. The safe and efficient transfer of assets and liabilities, maintenance of service continuity and enhanced collaboration by the successor bodies and agencies provided new challenges.

The end of the decade would see the abolition of the domestic rating system, the nationalisation of the business rate and the introduction of the community charge or poll tax. The safe and efficient winding up of old systems, the transition to new ways of working and the introduction of a brand new tax meant that the profession had to equip itself for enormous change –which it did. The poll tax did not last long. By 1992 we were getting ready to scrap it and return to a modified form of the domestic rates with a new property tax -the council tax.

#### Things can only get better?

As we moved into what we might describe as the start of the Institute's modern era – from 1997 – preparations were underway for very significant increases in public spending and investment. Council tax capping was to lay dormant for several years. Compulsory competitive tendering gave way to the pursuit of best value. Statutory borrowing limits were replaced with prudential borrowing. The private finance initiative was given a huge push from Whitehall. Reform of local government finance proved as elusive as ever. Central command and control strengthened. Change seemed to be endless and yet as we enter an age of austerity the last decade has seen much of the country's infrastructure replaced or renewed and perceptions of services by individual service users tend to be positive. Perceptions of organisations are much more negative.

Looking back over the past ten years or so of real growth in public spending the words of Tony Crosland, then Secretary of State for the Environment, spoken in 1975 that 'for the time being the party's over' seem haunting indeed.

#### How I became a CIPFA member

At school my intention was to read law at university with the idea of joining the colonial legal service – nobody had told me that the British empire was fast disappearing.

Anyway disastrous A level results in 1959 meant a rethink. Instead I applied to the civil service to enter the executive class grade and in 1960 I was allocated to District Audit which was then part of the Ministry of Housing and Local Government. District Audit had recently dropped its own internal exams for those of the IMTA (now CIPFA). This was a notable improvement as it meant more job flexibility. Unfortunately District Audit lagged behind local government in providing training for IMTA exams and I had to be content with a correspondence course with Alban and Lamb.

In 1962, I passed the intermediate exam and moved into local government, completing my qualification through day release with Hampshire County Council in 1964. This meant I could then do the Postgraduate Diploma in Public Administration as an external student at London University. I think it is true to say studying for the IMTA gave me a taste for exams which has never left me. I subsequently did a two year MSc in Accounting and Finance at the London School of Economics.

I am eternally grateful for the discipline to pass exams which the IMTA instilled in me. Even after 45 years I can still recall the great pleasure that passing the IMTA exams gave me.

#### From Colin Hubbard

As a higher education institution finance director I often attend meetings in London and one February early in the 1990s I was invited to represent the Standing Conference of Principals at the CIPFA annual dinner which on this occasion was held at Tailors' Hall, Threadneedle Street.

Giving myself ample time for the short journey from the hotel in Russell Square I donned my dinner suit and, fastening the single front button of the jacket, admired the smart reflection that beamed at me from the mirror. The button promptly flew off and rolled under the wardrobe.

No need to panic. I had a ruler that was long enough to retrieve the button and there were two bits of thread a good centimetre long hanging from the jacket. I was of the age when I clearly needed glasses for close work but refused to admit the fact to myself. The task of tying two short black threads on a black jacket behind a black button was somewhat of a challenge but fifteen minutes later it was secured sufficiently well that it would stay in place if I didn't fasten it. Running across Russell Square – without a coat as I didn't have one commensurate with the dignity of the event – I was confronted by a huge gathering of people outside Holborn station. The computer system was down and all stations were closed. Of course, with the tube shut down there wasn't a taxi or bus seat available in the whole of London. I decided to walk. It was windy and pretty chilly without a coat or operational button and as I crossed Holborn Viaduct it began to snow.

> I was the last guest to arrive at Tailors' Hall where the arrival of each guest was announced by an MC. With a deep layer of snow stuck firmly to the front of my suit I heard the announcement 'Mr Colin Hubbard representing the Standing Conference of Principals' bellowed across the room. Several hundred faces turned to see a bedraggled and sodden figure standing hesitantly at the door with a large puddle spreading from his feet.

### Five minute interview

With Ian Donovan, President of CIPFA South West and West of England

#### 1 What was your first impression of CIPFA?

#### 7 What is your favourite CIPFA moment?

My favourite and proudest CIPFA moment (other than passing the exam) was going to Dublin in 1998 for the Conference of the Regions and meeting Bertie Ahern.

#### 8 Is there a CIPFA member you particularly admire?

A CIPFA member I admire? Norman Fayers, former city treasurer of Bristol, who got me involved with the region and who resurrected the Weekend School here in the SWWE.

### CRC energy efficiency scheme has arrived

April 2010 saw the beginning of the introductory phase of the Carbon Reduction Commitment Energy Efficiency scheme (CRC). It is a mandatory energy emissions reporting and trading scheme. Organisations with annual half-hourly metered electricity use above 6,000MWh in 2008 are included in the scheme (70kVA metered use in Northern Ireland). For the public sector this includes qualifying:

- Local authorities and schools
- NHS trusts and NHS foundation trusts
- Police authorities

Fire authorities.

Registration for the introductory phase of the scheme opened in April and closes in September 2010. CRC is complex and you should make sure you understand all its aspects. The following is a very basic checklist of key points to be addressed in year one.

#### Are you ready?

Basic checklist for the first year of the introductory phase:

- 1 Confirm your organisational structure
- 2 Check whether your organisation, including any subsidiary, had a Half-Hourly Meter (HHM) settled on the
- half-hourly market
- 3 Determine the electricity used through all HHMs and assess whether your supplies exceeded the threshold of 6,000 MWh over the course of 2008
- 4 Look out for information and qualification packs sent to HHM addresses
- 5 Nominate someone within your organisation to oversee participation in CRC who can familiarise themselves with the requirements of the scheme
- By September register for the scheme or make an information disclosure to the administrator
  April 2010 to March 2011 monitor energy supplies for the year and collect records for evidence pack
- 8 April 2010 to March 2011 qualification period for second phase.

- Check to see if you still qualify
- 9 Take steps to ensure the quality and timeliness of all data required by CRC
- 10 Develop strategy for buying carbon allowances in 2011/12
- 11 Develop long term energy reduction strategy

CRC is complicated and there is a lot to understand in terms of the characteristics of the scheme, ensuring compliance, developing energy reduction strategies and getting to grips with carbon allowances trading. To help you understand and manage your organisation's participation in the scheme CIPFA has set up a Carbon Finance Network. The network will also look at other policy areas that address climate change and sustainability.






