3.2	JP commented that previous work with Chartered Housing could be redistributed due to relevance in current climate, JP to look at re-dating and pushing this work out	JP
3.3	JP asks all members to look at party manifestos and email with comments to shape CIPFAs work, CIPFA's manifesto will be reactive to the approach of main political parties	Members
3.4	Members raise points that analysis should follow like HSC reports, detailing the cost of inaction on certain areas. The impact of not doing anything or enough, is as important as current problems that need rectifying	
3.5	Panel discussed the blurred lines between housing and property investment that PWLB have not identified, there was an ambition that PWLB would differentiate loans on difference between investing in housing for regeneration and property investment for frontline services funding

4.1	DE outlined the changes with the Housing Advisory Network moving in to the Property division of CIPFA, it is hoped this move to a larger team means they can cover and push the wider strategic housing agenda as a team	
4.2	Members discussed the need for Housing Associations / Local Authorities to forge closer links, DE agreed on points raised and hope these closer links are an area the wider Property network can pick up on	
4.3	Members discussed the use of stress testing within local housing authorities, desire is this could be implemented as widely as possible while generating useful discussion, hoped with strong implementation recommendations can easily be laid out on identified problems

5.1	AH breaks down the Achieving Financial Excellence Programme and potential cross-synergies work within housing	
5.2	AH asked for collective list of issues within housing, the stresses and/or the offerings they could get from CIPFA to assist, these can then be developed to push Local Government

6.3	Members raised the point that ideally forward planning would be more useful with a 5 year sheet, in contrast to the current 3 years, as well as being able to account for non-financial deprecations e.g. boilers	
6.4	The Data and Analytics team currently have 5 Local Authorities who are undergoing testing with the new product, with a roll out intended to happen next year
