

Students were asked for their preference re F2F teaching or webclasses. Discounting those expressing a neutral / no-preference response:



When asked about the strength of this preference, all 12 answered in the 7-10 range (on scale of 1-10 where 1 is very low and 10 very strong)


When asked where they would prefer F2F classes be held: London – 7 Birmingham – 3 Newcastle / NE - 2
