8. Regional Events Plan 2022 (V15).

  CIPFA has now supplied the NQM info requested (to May 2022) to enable ceremony planning to start. An update list for early September is booked. Mike Driver has agreed to again present the certificates prior to our Annual Regional Dinner.
- (4) Zurich Municipal continue to sponsor our regional Zoom platform and Council is requested to suggest topics and/or presenters for inclusion in future virtual CPD sessions.
- (5) A regional newsletter is booked for next week and will publicise all of these autumn and winter events.
