### 1 Service Provision

### 2 Commencement and Term

The service will be provided on an annual subscription basis; the subscription period will start on 1 April and end on 31 March. Payment for the subscription will be due on presentation of a valid invoice.

By taking out a new subscription and accepting these terms and conditions the subscriber commits to pay the subscription fee. Where CIPFA has provided online access to the subscription service in good faith in advance of payment of an invoice, cancellation or non-payment will not be accepted.

### 3 Subscription Renewal

### 4 Cancellation
